Participation in any activity sponsored by the Club is entirely voluntary, and each participant must exercise judgment and care at all times to minimize the risk of inconvenience, injury, or death, to herself or himself, other members of the Club, and all other persons. The Club serves only as the sponsor of activities, and the Club, its affiliated organizations (MDSC and CMSC), and their directors, officers, trip leaders, event coordinators, and other employees, will not be responsible for or liable for any inconvenience, injury, or death that occurs during or as a result of participation in a sponsored activity. The Thunderbird Ski Club prohibits illegal use of any controlled substance at activities it sponsors.
